### HEAVY EQUIPMENT RENTALS

1. Equipment to be used within the Nageezi Community boundaries.
2. Equipment will be checked prior to be in good operating condition before it is used and thoroughly inspected upon returned by the Operator, and need be by Chapter Administration.

3. Renter assumes all responsibility for equipment while in possession of the chapter equipment. Equipment will be returned in good working order. Any damages or accidents will be reported to the Chapter Administration.
4. Renter shall be liable for any loss, theft, damage or destruction of equipment property rented.
5. Renter will repair or pay for all damaged equipment. Non-compliance of this policy will jeopardize future rental request.
6. DAY RATE IS BASED ON EIGHT (8) HOURS ONLY. Hours will be recorded.
7. Time will not be charged if a breakdown should occur during rental period.
8. Gooseneck will not be charged when hauling the heavy equipment.
